# Notice Concerning Completion of Conversion Work of Hotel to Office (BizMiiX Yodoyabashi)

MIRAI Corporation (hereinafter "MIRAI") announces today that the conversion work of hotel to office (BizMiiX Yodoyabashi, hereinafter the "Property") has completed and the tenants of the Property moved in from January 2021 as stated in "Notice Concerning Change of Property Name (WBF Yodoyabashi-Minami)" on June 16, 2020.

#### 1. Overview of the Conversion Work

MIRAI acquired the Property as the "Hotel WBF Yodoyabashi-Minami" in November 2018. As the former tenant filed for bankruptcy protection under the Civil Rehabilitation Law due to the impact of COVID-19, MIRAI was undergoing the conversion work of hotel to "ready-to-use serviced office" under the Property's fundamental restructuring strategy.

## Concept



The facility offers different 'mixes' such as 'mixture between serviced office and ready-to-use office' and 'mixtures of business opportunities among the tenants' Combining respective strengths of MIRAL and IDERA Capital of business opportunities among the tenants.' Combining respective strengths of MIRAI and IDERA Capital Yodoyabashi Management Ltd. who produced the overall concept, we aim to MIX UP the property value of the asset.
