Notice Concerning Restructure of Management and

1. Restructure of management

(1) Content of restructure

In order to expand the asset size of MIRAI and maximize the unitholder value in the future, Finance and Planning Division has been newly established for the purpose of improving efficiency of the operations and strengthening the management system of the Asset Management Company. Part of the work from the current Finance and Administrative Division will subsequently be transferred to Finance and Planning Division. In addition, due to the restructure of management, Finance and Administrative Division will be renamed Accounting and Administrative Division.

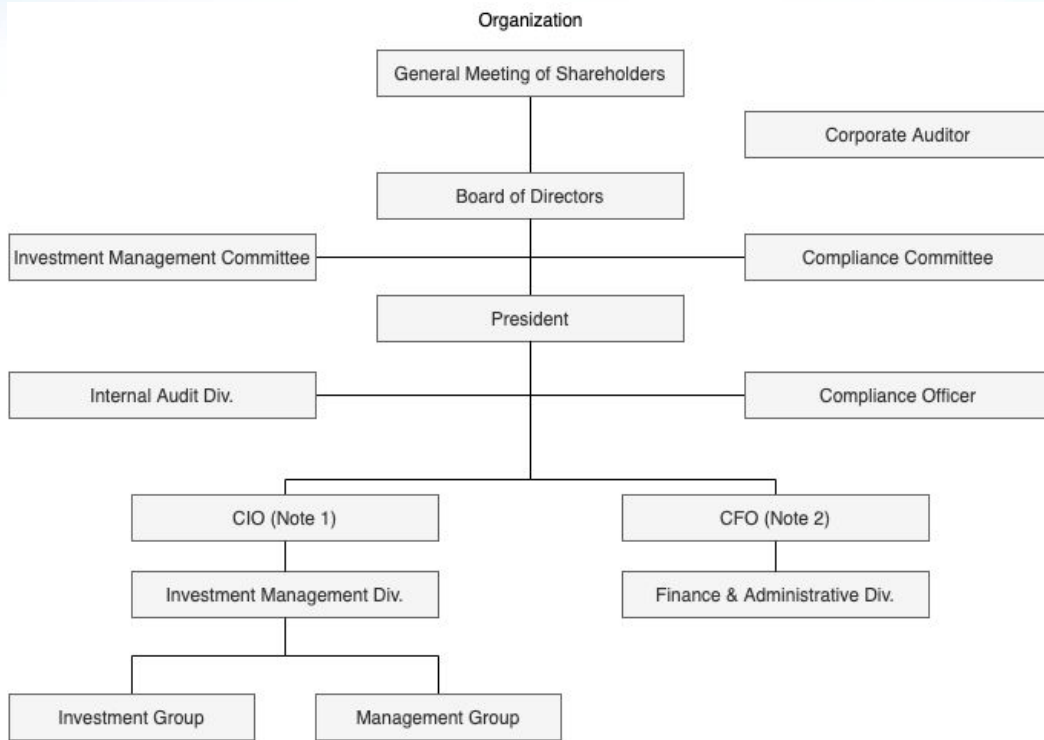

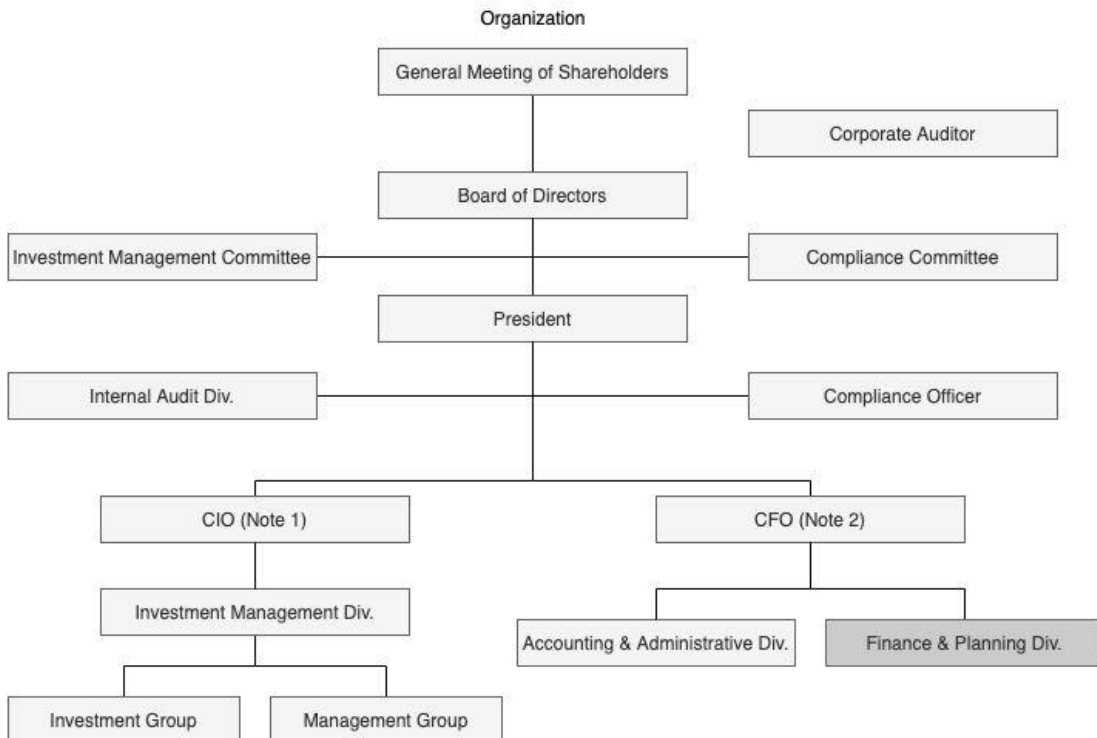
